**College Hostel Mess agreement for the session 2025-26**

**Part-I**

**TERMS AND CONDITIONS**

1. Applicant should have at least three years of experience in catering at Govt. Institute (preferably Girls Hostel).
2. Since this being a women college the contractor shall preferably appoint a female on the Hostel Mess Counter.
3. The Contractor must possess the requisite valid registration/license no. (If a cooperative society) issued by the competent authority for carrying out the business and shall be responsible for complying with all laws pertaining to the services in question as well as those pertaining to employment of persons under him. Suitable documentary evidence in this regard should be submitted along with the tender documents. Bids not complying to this condition will be summarily rejected.
4. Technical Bid and Financial Bid should be enclosed separately in one Envelope Financial bid should be properly sealed.
5. In case of tie in financial bid / rates priority will be given to female contractor if female contractor is not available then it will be finalised by "Draw of lots".
6. The Contractor shall serve the food items at such prices as mentioned in their financial bid.
7. The contractor should have FSSAI license.
8. The contractor should furnish affidavit regarding name of individual/ firm has not been black listed. The contractor shall bear all the expenses for running the said hostel mess including the cooking vessels and other equipments required for cooking while licensor shall not in any manner be liable to reimburse the expenses so incurred.
9. Earnest money in the shape of Bank draft/ Banker Cheque drawn on any nationalized Bank in favour of Principal F.L.T.M.S.B.P. Govt Girls College, Rewari Payable at Rewari for Rs. 5000/- should be deposited by the applicant as precondition for the participation in the process of the allotment of Mess. In the absence of EMD, no one shall be considered as applicant. The Earnest money shall be refunded to unsuccessful Tenderers after finalization of the contract. No interest is payable on the EMD.
10. The ALLOTEE shall have to deposit a sum of Rs. 50,000/- (Rupees Fifty Thousands Only) as interest free Performance Security deposit which will

be refunded after making necessary adjustments, if any, on the expiry of the contract.

11. List of documents to be included in technical bid.
  - A) Valid License from appropriate authority.
  - B) Affidavit regarding he/firm has not been black listed.
  - C) Undertaking regarding use of Agmark/FPO/FSSAI or such standard quality food article approved by relevant regulatory authorities.
  - D) Valid registration by an appropriate authority.
  - E) EMD of Rs.5000/- (Five Thousand only)
12. The contractor shall be required to pay:-
  - A) Water charges (Rs.200/- months) and Electricity charges (actual basis as per sub-meter reading) in every month. This amount shall be deposited by 10<sup>th</sup> of every month) as highest charges of DHBVN applicable.
  - B) Rs.50000/- as security that shall be refundable after the expiry of contract and no interest shall be payable on it. This may be adjusted in case of any dues/damages are reported during the tenure of contract period.
  - C) The contractor shall have to pay late payment charges @ Rs.50 per Day for late payment for the electricity and water charges separately. If not deposited by 30<sup>th</sup> of every month the contract shall stand cancelled.
13. The Contractor shall bear all the expenses for running the Mess and the F.L.T.M.S.B.P. Govt Girls College, Rewari shall not in any manner be
  - A) Liable for any damage caused due to incidents like theft, burn, fire, electric shock or bear any compensation for loss of life, damage or injury caused to its workmen while discharging their duty.
  - B) The Contractor shall not be entitled to use the accommodation allotted by the F.L.T.M.S.B.P. Govt Girls College, Rewari for any other purpose or business other than running the Mess.
14. The personnel appointed by the tenderers must have proper and clean uniform for their identification. The personnel so appointed should have the basic knowledge of personal hygiene and safe and clean methods of food handling, they should be of good character and decent behaviour. They should be provided with appropriate ID cards by the Contractor. The contractor shall solely responsible for the conduct/ behaviour of the staff employed by him in the college mess and shall solely be responsible for any mis-happening or undesirable incidence on account of the conduct/behaviour of the staff engaged by the contractor.

- A) A list of staff working in mess shall be forwarded to the police station concerned.
- B) The staff of the contractor shall abide by the instructions issued by the college authorities from time to time and their movement in the Hostel Rooms and Verandas shall be restricted.
15. The contractor shall run the mess for the benefit and use of the students of F.L.T.M.S.B.P. Govt Girls College, Rewari exclusively in the aforesaid premises.
16. The F.L.T.M.S.B.P. Govt Girls College, Rewari will provide suitable space for kitchen and dining within the college Hostel campus, Necessary Furniture for dining area will also be provided for College.
17. The contractor selected for mess service, will be required to maintain highest level of cleanliness and standard of hygiene with regard to the persons under his employment and utensils for serving the food. If, at any point the Mess & its premises are found to be unclean, the Contractor shall be held responsible and action deemed fit shall be taken by the Principal, F.L.T.M.S.B.P. Govt Girls College, Rewari.
18. The quality of the raw materials to be used for preparation of food in the staff Mess should be of highest standard and fresh.
19. The fuel to be used for cooking will only be LPG and shall be arranged by the Contractor.
20. The Contractor will be responsible for maintaining adequate number of persons engaged in cooking, distribution of food and disposal of garbage and left over food.
21. The list of personnel deployed for food preparation, handling and serving have to be intimated to the Authority from time to time.
22. There shall be no compromise on the quality of food supplied by the Contractor and if any such incidence of food adulteration is found, action deemed fit, including black listing the firm, shall be taken by the Competent Authority and all the rules of Prevention of Food Adulteration Act (PFA Act) will apply.
23. The agency will be responsible for complying all trade and security laws.
24. The Contractor shall not use the name of the F.L.T.M.S.B.P. Govt Girls College, Rewari in business dealing with other person or traders. Any conditional bid/application is liable to rejection of tender.
25. The person associated with preparation and distribution of food will be required to undergo periodical medical checkups as and when directed by F.L.T.M.S.B.P. Govt Girls College, Rewari to rule out the possibilities of

- communicable diseases/ infectious diseases, and anybody found suffering from such has to be kept out of work till he/she is fully recovered.
26. The Contractor will be responsible for such conduct of the persons engaged by him in the institute, which will be conducive for maintaining the harmonious atmosphere in the College Hostel and will be responsible for any act of commission and omission of such persons.
  27. The contractor shall be responsible for removal/disposal of garbage generated in the Hostel Mess.
  28. The successful applicant shall obtain a valid license under the Contract Labour (R&A) Act, 1970 and rules framed there under and shall continue to hold it till completion of the contract. The contractor should possess valid Registration Number.
  29. All pages of the tender and related papers are to be duly authenticated by Tenderer or Authorized Signatory on behalf of Tenderer.
  30. The College campus and Hostel is a “NO SMOKING ZONE”, hence sale and use of tobacco is prohibited.
  31. The sale and use of Liquor (alcohol) is also strictly prohibited in canteen area and premises.
  32. No child Labour shall be deployed.
  33. The Contractor shall keep in a conspicuous place in the Mess a Complaint book to record complaints and this book shall be open for inspection by the persons duly authorized by Principal, F.L.T.M.S.B.P. Govt Girls College, Rewari. The Contractor should make reasonable efforts to resolve the complaints recorded in the complaint register to the satisfaction of F.L.T.M.S.B.P. Govt Girls College, Rewari.
  34. The Contractor shall provide the bill to every customer. In case of excess charge found on any occasion, a fine of Rs. 1000/- will be charged for every excess charge.
  35. The Contractor should use AGMARK/F.P.O./FSSI or such standard quality food articles approved by relevant regulatory authorities. Certificate in this regard should be displayed prominently in the premises.
  36. An Officer authorized by Principal can check the quality of food and hygienic condition as per the govt. norms and a fine of Rs. 1000/- would be charged for every occasion of non-compliance. F.L.T.M.S.B.P. Govt Girls College, Rewari reserves the right to send the food samples served at the Mess, to relevant testing laboratories and take appropriate action on the contractor, if required.

37. **The Contractor will secure and submit to F.L.T.M.S.B.P. Govt Girls College, Rewari all applicable Licenses for running the Mess within 21 days of award of work or commencement of work, whichever is earlier.**
38. A penalty of Rs. 5000/- will be imposed on the Contractor for each day of unauthorized closing of Mess. If Mess remains closed for a week continuously, this agreement is liable to be cancelled and the Contractor shall be required to vacate the premises within 48 hours as per directions of college authorities.
39. F.L.T.M.S.B.P. Govt Girls College, Rewari shall have the right to terminate the agreement with the Contractor by giving one month's notice without assigning any reason.
40. The Contractor will vacate the Mess and hand over the possession of the premises on the expiry of the term of the contract or on termination of the contract. If the Contractor fails to vacate the Mess Premises on stipulated date or on direction then damage charges for the over stay at the rate of Rs. 10000/- (Rupees Ten Thousand) per day will be recovered from the Contractor out of the Performance Security. If Security deposit is insufficient to recover damage charges then the same will be recovered through the Courts of Law.
41. Security Money of the Contractor will be forfeited in case of breach of any condition stipulated herein.
42. For any dispute regarding quality/service and rates the decision of the Principal F.L.T.M.S.B.P. Govt Girls College, Rewari shall be final and binding to the Contractor.
43. The contract/tender, if awarded, shall be valid initially for one year from the date of award of contract subject to continuous satisfactory performance and on failure on this aspect by the contract the Competent Authority will reserve the right to terminate the contract. The period of the contract can be extended for further period by the Competent Authority on terms and conditions of the Principal F.L.T.M.S.B.P. Govt Girls College, Rewari.
44. The Successful Bidder shall execute an agreement on Rs. 100/- (Rs. One Hundred Only) Stamp Paper with the Principal, Govt. College for Women, Rewari within one week from the date of intimation of his selection.
45. The successful bidder shall take an insurance policy for an appropriate value for insurance against damage/loss due to fire accident in the Mess.
46. The contractor is responsible to maintain the infrastructure facilities provided by the college such as seating spaces, fan, electrical fitting, sanitary fittings etc.
47. All dispute shall be subject to jurisdiction of competent court i.e. District Courts Rewari.

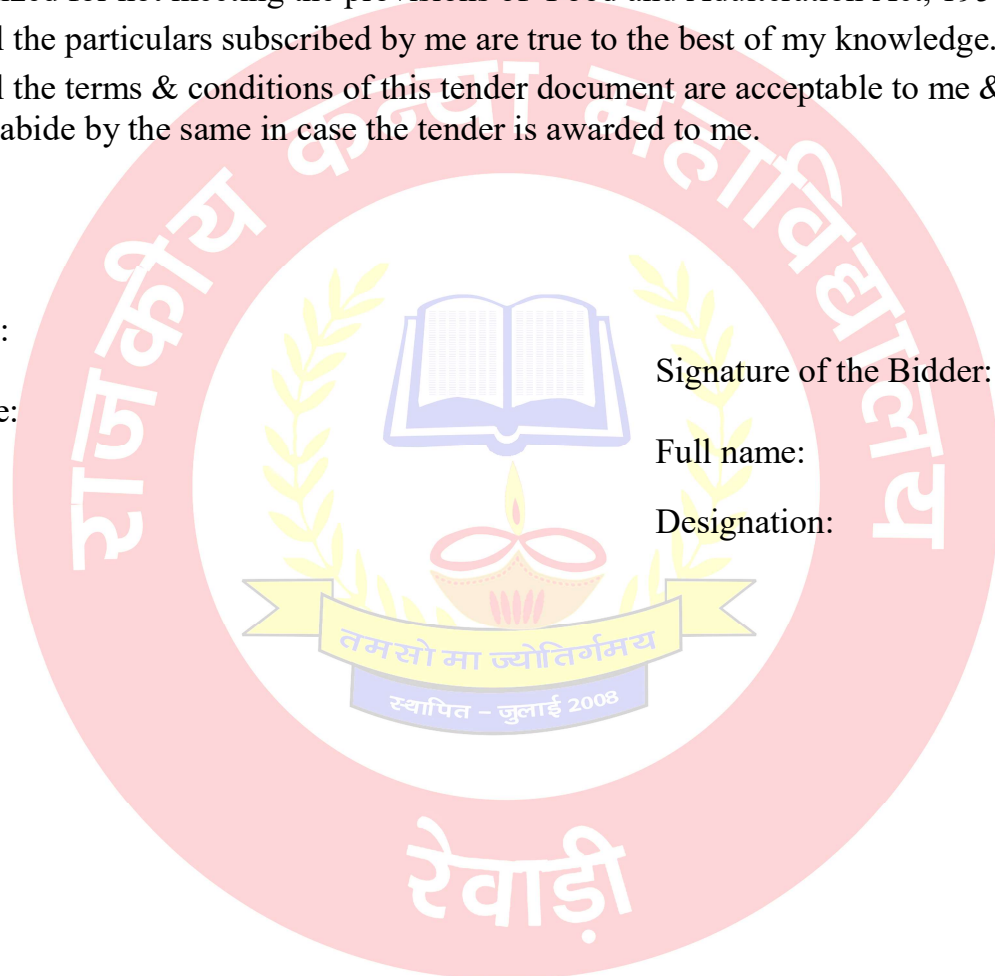
